2. Receive public comment.
3. Receive a report from Brad Dill regarding properties being developed by the District and to review, discuss, and take action on related matters.
4. Review and take action on matters relating to calling an election to be held on November 3, 2020:
 - a. Approve an Order calling for an election under Texas Health and Safety Code Section 775.0345;


- b. To review and take action to hold an election jointly with one or more other political subdivisions;
 - c. To review and take action to contract with County Elections Office for election services;
 - d. Order Approving and Appointing an Agent for the Election;
 - e. Order Appointing an Early Voting Clerk and Deputy Early Voting Clerk;
 - f. Order Establishing and Designating Election Precincts and Polling Places;
 - g. Order Establishing and Designating Early Voting Polling Places;
 - h. Order Adopting Form of Notice of District Election;
 - i. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election.

 - h. Lệnh Phê Chuẩn Mẫu Thông Báo Bầu Cử của Cơ Quan;

 6. Approve the minutes from the June 8, 2020 regular meeting and June 24, 2010 special meeting.
 7. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
 8. Review, discuss, and take action on paying the District's bills.
 9. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
 10. Review, discuss, and take action with respect to any pay applications approved by BRW.
 11. To review, discuss and take action on the selection of a landscaper for the District's properties in connection with the Requests for Proposals it published.
 12. To designate the entities and persons who will prepare the District's tax rate calculations for the 2020 District Tax Rate.
 13. Receive reports from the Klein Volunteer Fire Department.
 14. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
 15. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
 16. Receive a report about the ESD Administrator's activities and take any necessary action related to the report.
 17. To review, discuss and take action on any needed maintenance, replacements and improvements related to the operation of the District's fire stations, apparatus or equipment.
 18. Review, discuss and take action regarding any reports received from DBR, Inc.
 19. Review, discuss and take action regarding matters related to the construction of Station No. 3 Complex.
 20. Review, discuss and take action regarding matters related to the remodel of Station No. 6.
 21. Review, discuss and take action regarding matters related to the construction of Headquarters and Station No. 1 Complex.
 22. Review, discuss and take action regarding matters related to retired Station No. 5's property title.
 23. Review, discuss and take action regarding committee reports.
 24. Review, discuss and take action to confirm the date for a budget / financial forecast workshop.

25. Review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for August 10, 2020.
26. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting.
27. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
