6. To propose the District 2020 Tax Rate.


7. To schedule public hearings regarding the District's 2020 tax rate and the date of the meeting to adopt.
8. Receive a report from Brad Dill regarding properties being developed by the District and to review, discuss, and take action on related matters.
9. To review, discuss and take action regarding relocating the District's Administration Office.
10. To review and take action on matters relating to an election to be held on November 3, 2020:
 - a. Approve an Order of Election under Texas Tax Code Section 26.07.
 - b. To review and take action to hold an election jointly with other jurisdictions.
 - c. To review and take action to contract with Harris County Elections Office for election services.
 - d. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election.
10. Para repasar y actuar en relación a asuntos relativos a una elección a celebrarse el 3 de noviembre de 2020:
 - a. Aprobar una Orden de Elección bajo la Sección 26.07 del Código Tributario de Texas.
 - b. Para repasar y actuar en relación a la celebración de una elección conjunta con otras subdivisiones políticas.
 - c. Para repasar y actuar para contratar servicios electorales con la Oficina Electoral del Condado de Harris.
 - d. Par considerar y actuar sobre tales otras órdenes, resoluciones y asuntos pertinentes que sean requeridas o apropiadas para convocar la elección del Distrito.

 - c. Xem xét và tiến hành ký hợp đồng với Văn Phòng Bầu Cử Quận Harris cho các dịch vụ bầu cử.
 - d. Xem xét và thực thi các Lệnh, Nghị Quyết khác nói trên, và các vấn đề liên quan theo quy định hoặc khi thích hợp để yêu cầu tổ chức cuộc bầu cử của Cơ Quan.

12. Approve the minutes from the July 13, 2020 regular meeting.
13. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
14. Review, discuss, and take action on paying the District's bills.
15. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
16. Review, discuss, and take action with respect to any pay applications approved by BRW.
17. Receive reports from the Klein Volunteer Fire Department.
18. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
19. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
20. Receive a report about the ESD Administrator's activities and take any necessary action related to the report.
21. To review, discuss and take action on any needed maintenance, replacements and improvements related to the operation of the District's fire stations, apparatus or equipment.
22. Review, discuss and take action regarding any reports received from DBR, Inc.
23. Review, discuss and take action regarding matters related to the construction of Station No. 3 Complex.
24. Review, discuss and take action regarding matters related to the remodel of Station No. 6.
25. Review, discuss and take action regarding matters related to the construction of Headquarters and Station No. 1 Complex.
26. Review, discuss and take action regarding matters related to retired Station No. 5's property title.
27. Review, discuss and take action regarding committee reports.
28. Review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for September 14, 2020.
29. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting.
30. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
31. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.

32. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
33. To review, discuss and take action regarding matters discussed in the Closed Session.
