4. To review, discuss and take action regarding relocating the District's Administration Office.
5. To review, discuss and take action on a proposal received from Harris County MUD 24 regarding water and sewer service for the District's Station No. 1 Complex.


6. To review and take action on matters relating to an election to be held on November 3, 2020:
  - a. Approve an Order of Election under Texas Tax Code Section 26.07.
  - b. To review and take action to hold an election jointly with other jurisdictions.
  - c. To review and take action to contract with Harris County Elections Office for election services.
  - d. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election.
6. Para repasar y actuar en relación a asuntos relativos a una elección a celebrarse el 3 de noviembre de 2020:
  - a. Aprobar una Orden de Elección bajo la Sección 26.07 del Código Tributario de Texas.
  - b. Para repasar y actuar en relación a la celebración de una elección conjunta con otras subdivisiones políticas.

  - d. Xem xét và thực thi các Lệnh, Nghị Quyết khác nói trên, và các vấn đề liên quan theo quy định hoặc khi thích hợp để yêu cầu tổ chức cuộc bầu cử của Cơ Quan.

8. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
9. Review, discuss, and take action on paying the District's bills.
10. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.

11. Review, discuss, and take action with respect to any pay applications approved by BRW.
12. Receive reports from the Klein Volunteer Fire Department.
13. Review, discuss and take action on mutual aid or interlocal agreements regarding disaster operations, including revisions or amendments to the Harris County Basic Plan.
14. To review, discuss and take action regarding the District's contracts with Harris County Emergency Services District No. 11 and Cypress Creek EMS.
15. To review, discuss and take action regarding lease payments from Harris County Emergency Services District No. 11 for land at Station No. 6.
16. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
17. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
18. Receive a report about the ESD Administrator's activities and take any necessary action related to the report.
19. To review, discuss and take action on any needed maintenance, replacements and improvements related to the operation of the District's fire stations, apparatus or equipment.
20. Review, discuss and take action regarding any reports received from DBR, Inc.
21. Review, discuss and take action regarding matters related to the construction of Station No. 3 Complex.
22. Review, discuss and take action regarding matters related to the remodel of Station No. 6.
23. To review, discuss and take action on a proposal received from Harris County MUD 24 regarding water and sewer service for the District's Station No. 1 Complex.
24. Review, discuss and take action regarding matters related to the construction of Headquarters and Station No. 1 Complex.
25. Review, discuss and take action regarding matters related to retired Station No. 5's property title.
26. Review, discuss and take action regarding committee reports.
27. Review, discuss and take action regarding the District's Standard Operating Procedures Handbook.
28. Review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for October 12, 2020.
29. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting.

32. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
33. To review, discuss and take action regarding matters discussed in the Closed Session.
