7. To review, discuss, and take action on the District's Investment Policy for 2021.
8. To review, discuss and take action regarding the selection of a new company to manage and process the District's payroll.
9. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
10. To review, discuss, and take action regarding any matters related to the District's voter education and outreach campaign being coordinated by Neuman & Company.
