6. To receive the Klein Volunteer Fire Department's 2020 Audit report.
7. To receive a presentation from Dr. Ron Welch with Municipal Information Services.
8. Approve the minutes from the March 8, 2021 regular meeting.
9. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
10. Review, discuss, and take action on paying the District's bills.
11. To review and take action on granting exemptions for 2021.
12. To review, discuss, and take action on the District's Investment Policy for 2021.
13. To review, discuss and take action regarding the selection of a new company to manage and process the District's and Department's payroll.
14. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
15. To review, discuss, and take action regarding any matters related to the District's education and outreach campaign being coordinated by Neuman & Company.
