The District will consider and act upon the following matters:


1. Call the meeting to order, establish a quorum and identify other persons attending the District meeting who are present.

5. Approve the minutes from the June 16, 2021 regular meeting.
6. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
7. Review, discuss, and take action on paying the District's bills.
8. Review, discuss, and take action with respect to any pay applications approved by BRW.
9. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
10. To review, discuss, and take action regarding any matters related to the District performing an education and outreach campaign.
11. Receive reports from the Klein Volunteer Fire Department (the "Department").
12. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
