
The District will consider and act upon the following matters:

3. Receive a report from Brad Dill regarding properties being developed by the District and to review, discuss, and take action on related matters.
4. To receive the Klein Volunteer Fire Department's 2020 Audit report.
5. Approve the minutes from the July 12, 2021 regular meeting and the August 2, 2021 special tax proposal meeting.
6. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
7. Review, discuss, and take action on paying the District's bills.
8. Review, discuss, and take action with respect to any pay applications approved by BRW.
9. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
10. Receive reports from the Klein Volunteer Fire Department (the "Department").
11. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
12. Review, discuss and take action regarding purchasing voting equipment that satisfy the new election rules.
13. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
14. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
