 9. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
 10. To designate the Harris County Tax Assessor-Collector's Office to prepare the District's No New Revenue Tax Rate and related tax rate calculations for 2022.
 11. To review, discuss and take action to approve receipt of electronic (downloadable) Paid-Up and Delinquent Reports from the Texas Comptroller's Office.
 12. Receive reports from the Department.
 13. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
 14. Review, discuss and take action regarding any needed amendments to the Department's 2022 Budget.
 15. Review, discuss and take action regarding payroll processing for the Department.
 16. To review, discuss and take action regarding the District's and Department's health insurance.
 17. To review, discuss and take action regarding the District's and Department's life and accidental, death and dismemberment policies.
 18. To review, discuss and take action regarding the District's and Department's short term and long term disability policies.

19. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
20. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
21. Receive reports about the administrative personnel activities and take any necessary action related to the reports.
22. To review, discuss and take action on any needed maintenance, replacements and improvements related to the operation of the District's fire stations, apparatus or equipment.
23. Review, discuss, and take action with respect to any change orders or other construction matters related to the dispatch center located at Squyres Road.
24. Review, discuss, and take action with respect to any pay applications approved by Martinez Architects.
25. Review, discuss and take action regarding matters related to the remodel of Station No. 6.
26. Review, discuss and take action regarding matters related to property site for Station No. 7 on Louetta.
27. Review, discuss and take action regarding matters related to the construction of District's Administrative and Maintenance Complex.
28. Review, discuss, and take action with respect to any pay applications approved by BRW.
29. Review, discuss and take action regarding committee reports.
