9. Review, discuss, and take action on granting exemptions for 2022.
10. Review, discuss and take action on the payment of capital funding pursuant to the current budget forecast.
11. Receive reports from the Department.
12. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
13. To review, discuss and take action regarding the District's and Department's health insurance.
14. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
15. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
16. To review, discuss and take action on any needed maintenance, replacements and improvements related to the operation of the District's fire stations, apparatus or equipment.
