
The District will consider and act upon the following matters:

6. Approve the minutes of prior District meetings.
7. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments.
8. Review, discuss, and take action on paying the District's bills.
9. Review, discuss and take action on any software, technology or other capital purchases for the District.

11. Review, discuss and take action regarding submittals by the Department of request(s) for necessary purchases related to the provision of emergency services pursuant to the service provider contract and District budget.
